Certain fees include an additional markup by IPG in excess of clearing firm fee. The markup is utilized by IPG to offset operational costs, and any difference should be viewed as additional compensation to IPG. IPG may share a portion of the excess markup with its Financial Professionals. Commission charges for Brokerage accounts are noted at minimum levels, they may differ for certain account types, trades, or agreements in place.

These charges are in addition to your agreed upon advisory fee. Fees apply to advisory accounts with custody maintained at Pershing, LLC. Advisory accounts serviced by IPG in custody outside Pershing are subject to fees applicable to the client's designated custodian. Clients should review their respective custodial agreements upon establishing their asset custodial arrangement.

An inactive account is defined as an account holding a security position for a calendar year (Jan. 1-Dec. 31) without generating a trade, or free credit/margin interest of \$100 or more. Systematic reinvestment activity in Mutual Funds (SYS system) and/or exchange activity

in mutual funds (FundServ) will be considered as a trade. However, dividend reinvestment activity is not considered as a trade.

Data Access Services or Datamart Set-Up and Monthly Fees will be quoted on an individual basis and are not included in above fee schedule.

The IPG Annual Fee is charged to customer accounts during the month of December each year. Account closures prior to the month of December will be assessed as a **prorated** amount of the IPG Annual Fee.
